Topic: Thesis Support System

Objective

The objective of this project is the development of a collaborative system to support a common administrative process of a university, specifically the preparation of the diploma thesis.

The users involved in the system are Students, Instructors, and the Secretariat. A thesis concerns a specific topic, which is supervised and then examined by a Three-Member Committee of professors. Professors create topics as supervisors, and can participate in the supervision of topics of other professors as members of the Three-Member Committee. The assignment of a thesis topic to a student by a professor usually happens through an oral agreement or some other procedure by which the professor selects to whom they will assign their topics. Subsequently, the student must request that other professors agree to be members of the Three-Member Committee. Once everyone has agreed, they jointly sign the topic assignment application. The student then submits it to the Secretariat and can start working on their thesis.

During the preparation, the Instructor user monitors the student's progress. If they have multiple students, they must keep a record to know which students have taken a thesis with them, when they started, and how the progress is going.

At the end of their thesis, the student must be able to share the text of the thesis with the members of the Three-Member Committee, along with any supporting material (e.g. videos, photos, code, etc.). Then, the members of the Three-Member Committee together with the student must set a date for the presentation of the thesis. After the thesis is presented, the members of the Three-Member Committee record the student's grade on the relevant form (document), which the student then submits to the Secretariat.

ATTENTION: Before starting the design and analysis of the requirements of the work, you should carefully read the full regulation for the preparation of theses at the Department of Electrical and Computer Engineering (DECE) which is at the link:

Some procedures described in the regulations are not described in the following Functional Specifications as they are carried out outside the described application.

Functional Specifications

In the system there are three types of users: Instructor, Student, and Secretariat. Each type of user is authenticated for the use of the system through Login - Logout procedures: they can log in to the system through an appropriate username/password and log out of

it. The system should not allow the display of any content in case a user is not logged in. In case of an attempt to access any page without prior login, there is a redirection to the login page.

Instructor

The main options on the Instructor's home screen are:

- 1) **View and Create Thesis Topics:** The Instructor records a new thesis topic with a title, a short description (summary), and the option to attach a PDF file with a detailed presentation of the topic. The Instructor sees the list of topics they have created for assignment and can edit each of them.
- 2) **Initial Assignment of a Topic to a Student:** The Instructor assigns an available topic to a student, searching for them by their student ID or name. The topic is temporarily assigned to the student until the other members of the Three-Member Committee agree. The professor can cancel the assignment at any time before it is finalized.
- 3) **View List of Theses:** The Instructor sees a list of all theses in which they have participated in the past or are currently participating as a supervisor or member of the Three-Member Committee. They have the ability to filter the list based on the status of the theses (under assignment, active, completed, cancelled) and based on their role in them (supervisor, member of the Three-Member Committee). By selecting a thesis, they can see all the relevant information about it, i.e.: the basic information (topic, student, three-member committee), the chronology of the actions taken (status changes) and if it has been completed, the final grade of the thesis, links to the final text file in the library repository and the (form) grading report.

Depending on their role in a particular thesis, the Instructor can then proceed with appropriate actions regarding the status of the thesis (see point 6. Management of Theses). Finally, they have the ability to export the list of all displayed theses in a machine-readable format by selecting a file format (CSV and JSON).

- 4) **View Invitations to Participate in Three-Member Committees:** The Instructor sees a list of active invitations they have received to participate in Three-Member Committees. By selecting one, they can accept or reject it.
- 5) **View Statistics: ** The Instructor sees the following information in graphs:
- i. Average completion time of theses a) they have supervised and/or b) in which they are a member of the Three-Member Committee
- ii. Average grade of theses a) they have supervised and/or b) in which they are a member of the Three-Member Committee
- iii. Total number of theses a) they have supervised and/or b) in which they are a member of the Three-Member Committee

6) **Management of Theses:** Depending on the status of a thesis, the Instructor can perform the following actions:

- Under Assignment

- The Instructor can see the other Instructors Members who have been invited to participate and their response (invitation date, acceptance date, rejection date)
- The Instructor supervising the Thesis can cancel the assignment of the topic to a student. This automatically deletes any invitations and assignments of participation in Three-Member Committees.

- Active

- Regardless of role, the Instructor can record multiple notes related to the thesis work (short text up to 300 characters). The notes are visible only to their creator.
- As a supervisor, the Instructor can cancel the assignment of a thesis (after 2 years have elapsed since the final assignment, and by recording the number and year of the General Assembly that decided on the cancellation). The reason for the cancellation is automatically recorded as "by Instructor".
- As a supervisor, the Instructor can change the status to "Under Examination" so that the student can proceed with the further actions.

- Under Examination

- Regardless of role, the Instructor can view the text of the thesis uploaded by the student/candidate (draft).
- The Instructor as a supervisor can generate and display the announcement text for the thesis presentation. This option is active only if the student has completed the relevant presentation details (see Student).
- The supervising Instructor activates the ability to record the grade for the thesis and can record their own grade (in detail according to the individual criteria). They also see the grades recorded by the other members of the Three-Member Committee. The grades are recorded based on the criteria provided in the DECE Thesis Regulations.
- As a member of the Three-Member Committee, the Instructor records their grade for the thesis. They also see the grades recorded by the other members of the Three-Member Committee.

Student

The main options on the Student's home screen are:

- 1) **View Topic:** The details of the thesis work are displayed (topic, description, attached description file) and its current status, as well as the members of the Three-Member Committee (if they have been appointed). The time elapsed since the official assignment of the topic (if it has been done) is also displayed.
- 2) **Edit Profile: ** The student/candidate enters and manages their contact details (full postal address, contact email, mobile and landline phone).

3) **Manage Thesis Work**: Depending on the status of a thesis, the student/candidate can perform the following actions:

- Under Assignment

- The student/candidate selects the Instructors they want to be members of the Three-Member Committee and adds them, waiting for their response. As soon as the necessary number of invited Instructors (two) have accepted, the thesis automatically transitions to the "Active" status and any invitations to additional Instructor members are cancelled.

- Under Examination

- The student/candidate uploads the draft text of the thesis (file) which can be seen by all members of the Three-Member Committee. They can also upload links to other material (e.g. google drive files, youtube videos, etc.).
- The student/candidate records the date and time of the examination that they have agreed with the Three-Member Committee (a process outside the application). Depending on the examination method (in-person or online), the relevant information is recorded (examination room, or connection link for remote attendance).
- After the grades have been recorded by the members of the Three-Member Committee, the student/candidate can view the examination report in HTML format. They also record the link to the library repository (Nemertis) where the final text of their thesis is located.

- Completed

- Only the ability to view the thesis information, status changes, and the examination report is maintained.

Secretariat

The main options on the Secretariat user's home screen are:

- 1) **View Theses:** All "Active" and "Under Examination" theses are displayed. By selecting a thesis, the details of the thesis work (topic, description, and its current status) are displayed, as well as the members of the Three-Member Committee (if they have been appointed). The time elapsed since the official assignment of the topic (if it has been done) is also displayed.
- 2) **Data Import:** The ability to import a JSON file containing the personal information of students and instructors.
- 3) **Management of Theses:** Depending on the status of a thesis, the Secretariat can perform the following actions:

- Active

- The Secretariat records the AP number from the General Assembly in which the topic assignment was approved -- This is also needed for the examination report.
- The Secretariat can cancel the assignment of a thesis topic. The Secretariat records the number and year of the General Assembly in which the cancellation was decided. The

reason for the cancellation is automatically recorded as free text (e.g. "at the request of the Student").

- Under Examination
- Once the grade has been recorded for the thesis and the student/candidate has posted the link to Nemertis, the Secretariat can change the status of the thesis to "Completed".

System Functions Regardless of Authenticated Users

The system implements a publicly accessible endpoint (without authentication) that contains the announcements of thesis presentations, with the ability to parameterize the time range. The entire set of announcements covering the specified time range can be generated as an XML or JSON Feed using an appropriate parameter.

System Initialization

For the presentation of your work at the end of the examination period, the system should initially include at least 10 students, 5 instructors, and a sufficient number of topics and assignments, so that all possible states of a thesis are covered.

Each coursework team is asked to add a few students to the online system and 1-2 instructors. In this way, there will be enough records in the "common repository" for you to test your system.

Note that the common repository records DO NOT have usernames/passwords - Make sure to create the appropriate fields when importing the data into your system, e.g. you can use the emails as user names and generate random passwords when importing the data for each user.

Constraints

- 1. Groups of 3 (three) people maximum.
- 2. The core of your deliverable must be implemented exclusively with technologies taught in the course (PHP, JavaScript, Node.JS, HTML).
- 3. The appearance and functionality of the application is evaluated.

Deliverables

1. A summary report that will include:

- a. The database design (Entity-Relationship Diagram for relational databases, description of the basic data model for non-relational databases).
- b. Presentation of the application with a series of Screenshots. You can present them in the order described in the application specifications in the assignment, or following your own demonstration scenario for the application.
- c. The settings you made on your server to properly utilize the caching capabilities (caches, e.g. setting TTLs for different types of files). Mention the relevant configurations you made in the server configuration, or through .htaccess, or inline response header definitions and provide some screenshots from the browser's developer tools to show that the settings you made had an effect. Support the relevant choices regarding the rules you implemented or the values you selected for various parameters, with relevant references to technical articles or scientific literature.
- 2. The source code and a database export
- 3. All the above (1) and (2) are submitted in a compressed file on eclass.

Use of Technologies

- You will exclusively use open-source technologies for the database (MySQL, PostgreSQL, MongoDB) and any other functionality required by your work.
- The loading of data from the database for the presentation of content on the web pages must be done using **exclusively** AJAX techniques.
- In any case, avoid the use of PHP to create JavaScript code. The following examples are indicative of what you **should NOT do**:

- Attention to the database: Use appropriate indexes on the tables to speed up the queries.
- Particularly the front-end of the "Student" user should be accessible from mobile devices, so make sure to use a responsive design.
